### **Open Discussion**

- The board discussed and voted on the 2010 budget. The maintenance fees will stay at \$415.
- The board voted to revert to having our financials audited every two years – every even numbered year. These budget dollars will now be used to add “kiddie mulch” to the playground area in the Spring.
- The board voted to delay the discussion about resurfacing the pool to 2010. However, the pool will need to be resurfaced in the next couple of years. Original cost estimates are around \$20,000.
- The board has asked TCM to explain why we’ve not had a deed drive for two months.

- The financials were discussed and several questions asked that require TCM response..
- Seventeen homeowners have not yet paid their 2009 maintenance fees. That’s 5.7% of the homeowners here at HBTM. A property lien has been filed on those homeowners who have not yet paid their 2009 maintenance fees. Unfortunately, non-payment by these homeowners will affect your yearly maintenance fees.
- Patricia will get guidelines from the waste management company.
- Patricia is going out for bids on several of our contracts.
- Patricia to bring to next board meeting package of proposed changes to Rules and Regs as well as all information that will be sent to homeowners with the maintenance fee invoice.
- The board voted to have the Harvest Sun marquee repaired by November 15, 2009.
- The pool will need to be re-surface in the next year or so. Patricia will begin to get quotes for planning purposes.
- Precinct 4 Crime Statistics for RR MUD #1 were distributed via e-mail to the board. Crime in the entire area is increasing.
