## 2023 Pool Tag Registration/Assignment Process

- 1) If you are a homeowner or Renter in HBTM, you receive a pool tag if:
  - a. all maintenance fees for your address are paid
  - b. you are the homeowner/renter and any of your children who are 18 years of age of less.
  - c. Renter must show a copy of their current rental agreement.
  - d. All others listed on the Registration Form must show that their Driver's License shows that their address is the same as that of the homeowner/renter. (Also accepted: utility bill, ID card, or other objective evidence that they live at this address in HBTM). If Driver's License does not show HBTM address, you will need to come as a guest of Homeowner/Resident.
  - e. Minors under 14 years old must be within arms' length and accompanied at all times by an adult family member at least 18 years old who has a properly assigned adult pool tag.
- 2) You can use the pool as a guest of a homeowner/renter who have properly assigned adult pool tag if:
  - a. Only four (4) guests at a time are allowed per homeowner/renter address.
  - b. Each guest must pay \$1.00 to enter the pool area. Take a Guest pool tag and return it when you leave pool. If Guest pool tag is not returned the same day, homeowner/renter or their spouse/partner may be charged \$5.00 for tag replacement.
  - c. You must be accompanied at all times you are in pool area by homeowner/renter or their spouse/partner.
  - d. Minors under 14 years old must be within arms' length and accompanied at all times by an adult family member at least 18 years old who has a properly assigned adult pool tag.
- 3) If you live in HBTM and do not have a pool tag, you can come as a guest of another HBTM homeowner/resident or their spouse/partner who have a properly assigned pool tag, but you must pay \$25/person/day, complete the visitor's log sheet and use a visitor tag for the day.
  - a. HBTM homeowner/resident or their spouse/partner must accompany you at all times you are in the pool area.
  - b. If tag is not returned at the end of the day, homeowner/renter who accompanied you may be charged \$5.00 for tag replacement.
- 4) If you do not live in HBTM but live in RRMUD #1 or #2 area and are not a guest of a homeowner/resident or their spouse/partner, you can enter the pool area, but you must pay \$25/person/day, complete the visitor's log sheet and use a visitor's pool tag for the day. Be sure to return the pool tag when you leave the pool or you can be penalized.
- 5) <u>Pool Parties</u> See attached TAE documents "How to Arrange for a Pool Party (2023)" and "Exhibit G Pool Party Policy".
- 6) Additional Information
  - a. Covid waivers not required this year. Do not enter pool area if you are ill.
  - b. To enter pool area, sign-in on the provided log sheet
  - c. Introduce yourself to the lifeguards
  - d. Wear your pool tags at all times. Follow pool rules at all times.
  - e. Lifeguards have the final word and may ask you to leave the pool if pool rules are not followed.
- 7) <u>Pool Hours</u> 2:00 p.m. to 9:00 p.m. Tuesday through Sunday. Pool may close 10 minutes early for cleaning.
